

# PRESIDENT AND CHAPTER REPORT



A s I prepare to write my final report for this past fiscal year of July 1, 2019 to June 30, 2020, I go through all of the past reports of the 2019-2020 year and try to give you a snapshot of past activities as well as a few hints of what to expect in the coming fiscal year. Year end committee reports are also included in this newsletter edition.

Last year's report began by saying how rewarding and fun it is being involved in CCI. While I cannot dispute this, I ask myself, how much fun have we all had in the past few months?

Very challenging times for everyone, families, businesses, individuals, essential service workers and so too for volunteer organizations, condominium corporations, property managers and indeed all those who work in the condominium industry. Hats off to all of you for getting through these past few months and for doing such a great job under circumstances none of us could have ever imagined.

CCI has been challenged not only by the pandemic, but other issues as well. Our fifteen member Board of Directors has significantly reduced in size due to several resignations.

At this time, I do wish to thank Patricia Berry, Petr Kos, Debbie Buckingham, Jane Lecours and Susan Gagne for their commitment to our CCI, Manitoba Chapter. We miss you and wish you all well in your future endeavours.

That being said, we wish to encourage anyone who is interested in participating on our CCI Board of Directors. We encourage those with an interest in learning more about the condominium industry and others that may wish to offer their already knowledgeable expertise and experience from many years of living or working in the condominium community.

I cannot even begin to articulate the vast amount of knowledge I have personally gained by being a director of CCI, Manitoba Chapter and I certainly started out as a novice unit owner knowing next to nothing about condominiums.

It has been and continues to be a very rewarding experience and I wish to thank everyone for allowing me that opportunity, mentors, fellow members and all those who I have come to know in these past few years.

The CCI Manitoba Chapter bylaws allows for fifteen directors of which every year, five terms expire.

The term for a Board Director is three years.

Condominium owners are always welcome and encouraged to run for election, as are those who work as business partners and professionals in the community.

Elections are held yearly at our Annual General Meeting (AGM).

Board orientation takes place following the AGM and before the next scheduled Board meeting.

Team building sessions are usually held throughout the year. This allows newly elected CCI Board members to transition into the role as well as assisting them in getting to know veteran Board members and being welcomed as one of the team.

The Board meets monthly from September to June and all Board members are strongly encouraged to participate on at least one CCI Manitoba Chapter Committee. The President is included in all of the committees as ex officio. This past year, meetings have continued to be held monthly, however, since April, all of the meetings of the Board and CCI committees have been held on Zoom. When September begins, we will determine what is the best way for us to meet under whatever public health guidelines are in place at that time.

The AGM was scheduled for September 23, 2020 and was looking like it might even rival last year's meeting that was held at the Arctic Exhibit at the Assiniboine Park Zoo. After much deliberation about what restrictions may be in place in the fall related to the pandemic, we have changed the date to Thursday, October 8, 2020 and will hold the meeting virtually. It was a very hard decision to make, but we thought it would be the wisest approach. Please save the date and join us for the AGM. Look for notices in future email blasts and on the website with much more information on how to attend and participate.

I wish to thank all of the CCI Board members who must be commended for their commitment to our organization.

They attend monthly Board meetings, respond to members queries, attend

and chair CCI committee meetings, participate in monthly Lunch and Learns and attend CCI National Leaders Forums and other CCI events.

Thanks also to the Executive Committee, Krista Corley, Vice President, and Lori Ricard, Treasurer. The Secretary position is currently vacant. As per the CCI bylaws, the Executive Committee meets regularly to assist the President with the general management and supervision of the affairs and operations of the Chapter. The Executive Committee also acts as the Finance Committee.

Thanks also to Deniz Fraas, our previous Chapter Administrator who resigned effective March 30, 2020. We are extremely grateful to welcome back in our midst, a familiar face, Millanne

Baxter who previously worked as our Chapter Administrator. Millanne took over the position at the height of the pandemic and has helped us immensely. We can't thank Millanne enough for stepping into the role and making the transition so much easier for all of us.

At the outset of this report, I mentioned the challenges for us during these times. Lunch and Learns cancelled, Board and committee meetings held virtually, condominium corporations looking to us for advice on pandemic related issues affecting condominiums, issues around rescheduling and holding the AGM virtually, Presidents Forums not held and the CCI National Spring Leaders Forum cancellation.

As we look ahead, planning is difficult as no one knows at this time what the coming year will bring and indeed if things will ever be done the way they once were.

As all organizations have had to do, we have adapted and are grateful that our challenges are small compared to the many challenges others have faced.

So enough about challenges. I must say that we cannot lose sight of the amazing job we, including all of our members, property managers and others did to fight the budget proposal the City of Winnipeg put forward to stop garbage collection at condominiums.

Property Managers helped us engage our members in lobbying city councillors and speaking out in the media. It was a very successful campaign that we definitely can claim as a victory.

The city in early March withdrew the proposal but we learned, "you can take on city hall" and you can win. Thanks to all of you.

Another success was our handling of COVID-19 issues. Doug Forbes and Delaney Vun held a well attended webinar answering all questions relating to condominiums having to manage the issues arising out of the pandemic. The COVID-19 newsletter was superb. There were some challenges getting it into the hands of our members, so if you did not receive it, please visit our website.

Distribution of most CCI material relies on property managers as we do not have email addresses for individual unit owners of condominium corporations. We cannot thank property managers enough for their assistance.

The Education Program led by co-chairs Krista Corley and Connie Dame did an outstanding job this past year. As mentioned, Lunch and Learns were cancelled for the months of March and April but previous Lunch and Learns were very well attended, received great

evaluations and all of them were videoed and made available as podcasts to members. Thanks to the Education committee and their team for beginning this initiative and many thanks to Connie Dame and Karma Property Management Ltd. for sponsoring the podcasts.

For now, the Education Committee are planning Lunch and Learns for:

September 17, 2020 on the topic of Virtual AGM's, a "how to" on accomplishing this as well as bylaw changes that could allow for these meetings to be held this way in the future.

October 22, 2020 on the topic of Condo Insurance, particularly

differences between condo corporation insurance and condo unit owner insurance, discussions on deductibles, rising costs and condo security issues.

November 19, 2020 on the topic of Financials, including how to budget, reserve funds, balance sheets, etc:

Stay tuned for information on how to access these Lunch and Learns virtually and where to attend if we are able to hold face to face meetings. We will continue at Canad Inns if possible at the usual 11:30 am time slot on the above dates.

The Newsletter Committee was chaired by Susan Gagne and then taken over by Alan Forbes midyear. They and their team produce an outstanding publication that continues to receive rave reviews from members. We in Manitoba are the only Chapter in Canada sending copies to each and every individual member. Often this is the only contact we have with some unit owners and is a great benefit for those not actively engaged in the organization. If you have ideas for articles, or perhaps you may wish to contribute an article, please let us know. I love my Condo is always looking for submissions.

Delaney Vun and Doug Forbes co-chair our Government Relations Committee and did an excellent job lobbying the government with regard to condominium corporations having the ability to hold their AGM's virtually. The government responded positively. Thanks for a job well done. We hope to hold a Lunch and Learn in early fall to assist condominiums with lessons on how to hold an AGM virtually. Delaney Vun recently volunteered to chair the Communications and Membership Committee, following the resignation of Debbie Buckingham. This committee is responsible for approving all communications, marketing and promoting CCI to members and non-members. This past year a lot of discussion ensued on the issue of how to become more effective as an organization on social media. These discussions will continue in the coming year.

The AGM & Sponsorship Committee is chaired by Krista Corley and the committee has done an outstanding job. A very new Chapter committee who went over and above in planning another exciting AGM for this year that will now be held virtually on October 8, 2020. A disappointment for sure, but the venue that was previously booked has been rescheduled for the 2021 AGM. The venue would have been another exciting place to hold our AGM with lots of surprises in store, however, for now you will have to wait and see.

In terms of sponsorship, the program has been changed to allow more opportunities. Look for the new sponsorship opportunities coming soon on our website.

The CCI National is busy planning a virtual Fall Leaders Forum scheduled for early November 2020. This session was to have been held in Kingston, Ontario but has been rescheduled as a virtual forum.

Jane Lecours previously served for many years as our Manitoba Chapter

National Representative and did a great job. With her recent resignation, Alan Forbes has agreed to take on the position until after our CCI Chapter AGM. Many thanks to Jane and to Alan.

Doug Forbes currently chairs the National Executive and they too have been busy with the challenges facing a national organization in unprecedented times. Thanks to Doug for his skills, talent, experience and expertise at the provincial and the national level.

Thanks to Petr Kos and Pamela Pyke who currently participate as non Board member volunteers on CCI, Manitoba Chapter Committees.

We encourage those who may not



#### **COMMUNICATIONS & MEMBERSHIP COMMITTEE**

The Communications and Membership Committees is responsible to increase both the membership of CCI-Manitoba, as well as the Chapter's outreach to the greater condominium community.

This past year we experienced a decrease in membership, and have been working hard to incentivize former members to become members again and to prove CCI's value as we recruit new members. We are very proud of our recent accomplishments, including successfully lobbying against the City of Winnipeg's proposed cuts to garbage service and our role in persuading the Province, in light of the public health orders around COVID-19, to issue an Order allowing general meetings of unit owners to be held electronically, and extending the deadline for the holding of annual general meetings. We believe these successes demonstrate the benefits of CCI and our commitment to working on behalf of the condominium community.



Note that each hike name listed has an embedded hyperlink which can be used from our PDF version of our newsletter (accessible via https:// cci-manitoba.ca/login) to see the hike details. Since many of the hikes use AllTrails links (https://www.alltrails.com) you can preview them in advance, print out trail maps, or alternatively you could just download the AllTrails app to your smartphone from the App Store or Google Play. While you don't need the App active throughout the duration of the hike, it is very useful for finding trailheads, or if the trail has many branches - just open the App and see your position with respect to the plotted trail (the App also helps greatly if you get off the beaten path i.e. lost).

If the listed hikes don't catch your fancy, consider trying one of the many walks in and around Winnipeg listed in the *Prairie Pathfinders Winnipeg Walks*, which should be available at your favourite bookstore and is also available at the library. If you're looking to get beyond the Perimeter Highway, consider *A Daytrippers Guide to Manitoba by Bartley Kives* or *Manitoba, Naturally by Bill Stillwell.* So if you're tired of the 'cooped up Covid' blues, consider getting into the great outdoors, hiking or walking about, and filling your lungs with some fresh air. As an added bonus, it will help you build up an appetite for a favourite meal and beverage.



# STAYCATION OPTIONS - TRY BIRDING



f you still are worried about travelling too far this fall because of the pandemic and only looking at staycations, consider exploring the great outdoors by trying birding. It is a great excuse to get outdoors, especially just after sunrise (for you early birds) or in the evening a few hours before dusk (for you night owls). Alternatively, depending on where your condominium is located and the landscaping features on your grounds, you may be able to enjoy birding from the comfort of your balcony or walking around your property. If you get out to a park or rural setting, you'll have the opportunity to meet a number of very interesting people when you walk around with binoculars hanging around your neck and more importantly, you need not worry about being fashion conscious at all.

You may not be aware but Manitoba is a birding hotspot - we are on the spring and fall migratory pathways, so on a given day, you'll easily be able to find 50+ bird species in an hour or two. Good birding locations in Winnipeg include Assiniboine Park and Fort Whyte. Outside of Winnipeg, any of the Provincial Parks will usually yield numerous species http://www.gov.mb.ca/sd/parks/ park-maps-and-locations/index.html.

If you are interested but unsure how to start birding, get yourself of copy of a *Peterson Field Guide for birds of eastern North America* and possibly contact one of the local nature organizations, such as Nature Manitoba http://www.naturemanitoba.ca, which has an abundance of birding resources and links, and often has birding outings organized in the spring and fall. If you are already more comfortable with idea of birding on your own, download a copy of the Manitoba Bird Checklist http://www. naturemanitoba.ca/sites/default/files/MB\_bird\_checklist.pdf, call up a few

There are numerous online resources, such as https://www.audubon.org/birding-by-ear plus there are smartphone apps such as 'Merlin' by Cornell Labs, available in the App Store and Google Play.

So consider birding in Manitoba as part of your staycation plans during the pandemic. It will be an interesting and enjoyable experience, while helping you keep healthy and active.





# STAYCATION OPTIONS - CYCLING & BIKING

f you are stuck at home during the pandemic avoiding travel to other Provinces with higher Covid infection rates, consider getting on your trusty bicycle and try out one of the bike trails in your area. As well, with lower traffic volumes due to the pandemic, you can feel comfortable riding on most roads, whether around your neighborhood or even across town. Don't worry about having to ride in traffic - most cities and towns now have bike trails and also have maps showing recommended routes through the various low traffic-volume streets well suited to biking, along with the trails. For example, there are online resources that can be downloaded to your smartphone, such as the Brandon Bike and Trail Map, www.brandon. ca/images/pdf/Recreation/shareTheRoads.pdf, and the Winnipeg Cycling Map, winnipeg. ca/publicworks/pedestriansCycling/maps/ default.stm. Speaking of smartphones, there is an excellent App ridewithgps.com that can be downloaded from the App Store or Google Play.

Do you regularly ride a bike or have you not been on one since childhood? If you haven't ridden for a while, don't worry as getting back on is easy - it is '*like riding a bike*'. I've been riding a bike for almost 60 years now, sometimes just recreationally around the neighbourhood and sometimes commuting to and from work. For several years I put on over 3000 km biking between my home and work. Fortunately, I never had a major incident but did have a few close calls. While I've been honked at, cut-off, and told to get off the road and onto the sidewalk, these are the exceptions rather than the rules. Generally, I've found the great majority of drivers very supportive and accommodating of cyclists on the road.

How about you, does your blood pressure rise when cyclists and motorists point fingers at each other as the sole cause of all traffic problems? In my view there are similar proportions of good and bad drivers, whether they be in their cars or on their bikes. By the way, have you ever tried to ride in a sharrow lane with a bus right behind you? When I was still working, this was a frequent occurrence because I had to bike a portion of my trip on Regent Ave by Kildonan Place. I always felt sorry for the bus drivers, who couldn't change lanes because of traffic, so I'd often hop the curb, let them pass and hop back into the sharrow lane. They would always respond with a friendly wave of appreciation or a flash from their break lights.

Finding a good cycling map such as the ones mentioned above will open the doors for you to see other areas of town in details that you would miss while driving in a car. Maybe you like looking at expensive homes, or different vintages of

architecture or just like riding on a street shaded by large elms. If you live in the north part of Winnipeg, you can easily incorporate into your route the Chief Peguis Trail, Kildonan Park, Scotia Street or Kildonan Drive, the river path to the forks and your favorite beverage at The Common at the Forks. For those on the south or west side of Winnipeg, the trails along Bishop Grandin and Kenaston can be easily incorporated into a route including Fort Whyte, Assiniboine Park and Wellington Crescent or Wolseley Ave. For those of you looking for a longer ride, consider Henderson Hwy out to Lockport for a hot dog at Skinners or Half Moon, with an extra loop to the Larters golf course or lower Fort Garry.

So, get off the couch and onto your bike and start exploring our great Province. Besides the scenery change you'll also end up looking and feeling better, and build up an appetite for your favorite foods and beverages.



#### **CCI NEWSLETTER DELIVERY DILEMMA**

We've had a number of inquiries about the possibility of transitioning to electronic delivery for your quarterly *Condominium News and Views* instead of continuing with paper copies. Just recently, we received this one from one of our members

I would like to suggest that CCI discontinue the magazine copies of the Condominium New and Views. In this day and age, where we should all be concerned with the conservation of our ecosystem, I for one would much rather read it online. It must be a huge expense to print and deliver these magazines to all subscribers. Not to mention, it is a bit of a pain to deliver them to all unit owners!

Thanks for listening and keep up the good work!

The member raises valid points, especially with concerns for the ecosystem. As well, our cost at CCI Manitoba to print and deliver it to all members using both couriers and CanadaPost is one of our larger expense items, and this cost has to be passed onto our members through their membership fees. As well, deliveries for many Condo Corporations are drop-shipped to their already busy Property Manager, who then have to take time to deliver to the unit owners, and are likely passing on this extra distribution cost to the Condo Corporation.

We had started working on our Spring 2020 edition in April, during the height of the pandemic lockdown and completed deliveries to members by the end of May. Through the process we were concerned about whether the delivery addresses on file would be open to receive the newsletters, so we contacted all members asking for direction. The sample email below is what was sent out for condo corporations.

Dear <Property Manager / Condo Corporation>,

CCI Manitoba is planning for the production run of the spring newsletter with delivery by the end of May. Given the current situation with COVID-19, we are looking at possible alternate delivery options, including:

• **NO CHANGE TO DELIVERY:** We will deliver the newsletter as per usual.

• **DELIVERY DIRECT TO CONDO CORP:** Delivery of newsletters directly to the Condo Corporation with an address provided by you, along with the name and unit number of the person accepting receipt (with phone# and/or buzz code if required for the property), who will then deliver to the unit owners.

• **REDUCED COPIES DIRECT TO CONDO CORP:** Delivery of a reduced quantity of newsletters directly to the Condo Corporation with an address provided by you, along with the name and unit number of the person accepting receipt (with phone# and/or buzz code if required for the property), who will then place in the lobby for unit owner pickup.

• **ELECTRONIC DISTRIBUTION:** Forgoing a delivery of the physical copy of the spring newsletter edition, we would provide you with an electronic copy for you to forward through your normal electronic distribution list, and an electronic copy will also be available on the CCI website (we will provide login information).

Based on the responses we received, fewer than 10% of the recipients had interest in changing the delivery method for the Spring Edition, so for this Summer Edition we reverted back to normal with the previously used methods.

So what do you think about the idea of receiving the newsletter electronically for your office or Condo Corporation? Doing so could potentially remove the pressure on CCI to raise membership fees in the future. If you are a Condo Corporation receiving the newsletter via your Property Manager, what would you think about the direct delivery option? While it would require someone to do the onsite distribution, it would probably save you a bit of money by not having the Property Manager doing it.
